OVERVIEW

Catherine has an extensive commercial and chancery litigation practice and has long been highly recommended by the directories, regularly being nominated for various awards. She was Chairman of the Young Barristers' Committee in 2004, the Chairman of the Bar Conference (Human Rights – Taking Liberties) in 2007 and the elected Treasurer of the Chancery Bar Association from 2008-2012.

Catherine read law at Cambridge and went on to read the LLM in which she achieved a first. She was a Queen Mother Scholar and a Harmsworth Entrance Exhibitioner and has been in practice at what is now Maitland Chambers since completing pupillage in 1999.

appointed as a Deputy Insolvency and Companies Court Judge in 2016 and been a member of the Insolvency Rules Committee since 2013 (appointed pursuant to s413 of the Insolvency Act 1986 following an open competition).

In 2022, Catherine was named Company/Insolvency Silk of the Year by Chambers UK and as Insolvency Silk of the Year by Legal 500 in 2020.
