OVERVIEW

George's practice extends across the full range of commercial disputes, both in court and arbitration. His cases have covered commercial contracts, civil fraud, asset recovery, shareholder disputes and insolvency, often involving a major international element. He is adept at navigating the full spectrum of interim orders such as asset freezing, injunctions, and jurisdiction challenges, through to trials and final hearings. Along with his domestic court work (principally in the Commercial Court and Appellate Courts) and offshore court work (principally in the BVI and Trinidad), George is regularly instructed in LCIA, ICC, and ad hoc arbitrations. He is consistently highly recommended in the legal directories for all his areas of expertise.

COMMERCIAL LITIGATION & ARBITRATION

George's practice covers business agreements and contract disputes of all kinds (including shareholder disputes), both in court and arbitration. He has extensive experience as a trial lawyer and in all aspects of interim disputes in the English Courts and overseas, and has acted as counsel in many LCIA, ICC and ad hoc international commercial arbitrations.

CIVIL FRAUD

George acts for international clients in fraud disputes in the commercial courts and overseas, and has appeared in high profile cases including the Libyan Investment Authority Litigation, the Ablyazov Litigation and the Namalco Litigation.

- **Namalco Construction v EMBD** [2018-2023]: acting for the State-owned Defendant in a 6-week trial of a \$1.4 billion construction claim in the Caribbean Court of Justice (Trinidad & Tobago) concerning conspiracy in relation to five large scale infrastructure projects.
 - **Tugushev v Orlov** [2019-2021] : a dispute over the ownership of 'Norebo', one of the largest fishing enterprises in the world, concerning allegations of conspiracy and fraud. Generated notable judgments on jurisdiction ([2019] EWHC 645(Comm)) and the discharge of worldwide freezing orders ([2019] EWHC 2031(Comm)).
 - **Libyan Investment Authority (LIA) v Societe Generale and Others** [2016-2017]: acting for the Fifth Defendant claims brought by the LIA to set aside \$1.5billion of structured investments with SocGen on the basis that they formed part of a corrupt scheme involving the alleged bribe of Libyan state officials.
 - **Tatneft v Bogolyubov and Others** [2017] : \$380m fraud claim by a Russian state oil company against four Ukrainian oligarchs. Obtaining freezing and asset disclosure orders.
 - **JSC BTA Bank v Ablyazov** [2011-2015]: representing the principal defendants in this major international commercial dispute in relation to the affairs of a Kazakhstan bank. Particular involvement in committal proceedings, injunctive relief, summary judgment applications and appeals in the Commercial Court, Chancery Division, Court of Appeal and in the Supreme Court of the Eastern Caribbean(BVI).

OFFSHORE & TRUSTS

Much of George's work has an international element, and so he frequently represents international clients in overseas courts and arbitrations.

As a member of the Bar of the Eastern Caribbean Supreme Court (BVI), and the Trinidad & Tobago Bar, George undertakes advisory and advocacy in that region. His recent notable cases include:-

- **Namalco Construction v EMBD** [2018-2023]: acting for the State-owned Defendant in a 6-week trial of a \$1.4billion construction claim in the Caribbean Court of Justice (Trinidad & Tobago) concerning conspiracy in relation to five largescale infrastructure projects.
- **Wilton Trustees v AFS Trustee** [2022]: acting for six defendants in largescale multi-party claims in the Eastern Caribbean Court(BVI), involving allegations of breach of trust, conspiracy, and fraudulent misrepresentation.
- **JSC BTA Bank v Ablyazov** [2015-2016]: representing the principal defendants between 2011 and 2016 in this major international commercial dispute in relation to the affairs of a Kazakhstan bank.
