OVERVIEW

Since completing pupillage in 2023, Kendya has gained experience across the breadth of Chambers' specialisms, including company disputes, insolvency, and complex civil fraud litigation. She has since been developing a commercial chancery practice which encompasses a broad range of company and insolvency work. Kendya was supervised during pupillage by Rowena Page, Richard Fowler, Thomas Fletcher, and Caley Wright.

Kendya has successfully appeared unled in High Court proceedings including **Little and another v Olympian Homes Ltd** [2024] EWHC 1766 (Ch), a case in which the High Court considered contractual waiver by estoppel in the context of an application to set aside a statutory demand, and in **Braunford and another v Allain** [2025] EWHC 2545 (Ch). She has also had experience being led as part of a counsel team in complex litigation across Chambers' specialisms, including **Infinni Innovations S.A. v OFMS Limited and others** [2026] EWHC 470 (Comm), led by Arnold Ayoo.

Kendya has a particular passion for charities disputes and advisory work. She delivered the "Legal Update" at the Charities Law Association Conference in 2024 and has been elected a junior representative director on the executive committee of the Charity Law Association. She regularly undertakes pro bono work as an Advocate member, and raised £2,296 for Advocate by running the London Landmarks Half-marathon.

Before coming to the Bar, Kendya received a first-class degree in History & Politics from New College, Oxford. She was president of New College Junior Common Room (the body representing undergraduates) in 2018-19. She then completed her Graduate Diploma in Law and Bar Vocational Studies at City University, as the Pump Court Tax Chambers scholar in 2022.
