OVERVIEW

Focused on advocacy and case strategy and instructed in both litigation and arbitration in England and overseas, Richard has significant experience in high value disputes, frequently involving cross-border issues and freezing orders. Aside from England and the Eastern Caribbean, Richard has been called *ad hoc* in a number of jurisdictions including in the Cayman Islands, Bermuda, Gibraltar and the Isle of Man. He is also on the Register of Legal Practitioners for the DIFC Courts. He has sat as an arbitrator on a number of occasions, been instructed to provide an expert determination, and has appeared as an expert witness on English law before a Californian Court.

Richard has experience of working with lawyers from a large number of other jurisdictions and has also travelled extensively, both to appear and to have consultations with overseas lawyers and clients.
